

# Parker's Pajama Party Policies

## **Reservations**

We highly suggest to order your party as soon as possible. Dates quickly fill up. If you request last minute dates we may be able to accommodate with a rush fee. Rush fees can vary from \$50-\$200 depending on the items that are ordered.

## **Deposit**

In order to hold your date a deposit of \$200 is required. \$100 of that will go towards your remaining balance and the other \$100 will serve as a security. Funds will be refunded 48 hours after your event pending no damage has been done to any of the products.

## **Payments**

4 weeks prior to event 50% of your remaining balance minus the deposit will be due and the remaining balance is due 2 weeks prior to the event. All payments are made through paying the invoice powered by Paypal, which can be paid with credit/ debit cards. Credit card payments will incur a 4% fee.

## **Event space requirements**

Pajama parties should be held in a large cleared out space. **STAFF WILL NOT MOVE FURNITURE.** Someone will need to receive one of our staff members as they arrive and someone will need to be in attendance during the pick up as well.

Hotel sleepovers may be ideal. Please be sure the room that you reserve for the party can accommodate the rental.

## **Cancellations & Refunds**

There will be no refunds given for your deposit or previously paid party balance. If you need to reschedule for any reason, we will offer you the next available date.

## **Liability**

Parker's Parties assumes no responsibility or liability for accidents or damages. In the event of damage or loss of Parker's Parties inventory and/or damage or loss to the party's location, the financial responsibility lies entirely on the client.

Parker's Parties is not responsible for allergic reactions or any other medical reaction during the party. There should be no sharp objects that may puncture the air mattress.

For purposes of maintaining the highest quality of our linens and fabrics, we kindly ask that beverages be light-colored or clear if eating and drinking on the mattresses and please refrain from eating items containing tomatoes, tomato sauce, or dark-colored jellies in the tents.
